## Trade association climate lobbying alignment - Supplement

Sempra conducted a mid-cycle review of certain trade associations analyzed during the 2023 assessment on climate lobbying alignment described in Sempra's 2023 Corporate Sustainability Report. The mid-cycle review assessed trade associations found to be partially aligned with Sempra in their climate-related policy and advocacy positions as well as one trade association's alignment that was adjusted from aligned to partially aligned. The results of the mid-cycle review include only a representative list of climate-related/energy policies considered partially aligned or misaligned with Sempra's positions and do not reflect all areas evaluated in the 2023 assessment.
